1. This is a continuous rental agreement. Monthly rental fees will be accrued until the instrument is returned to Hermie's. Renter is responsible for this instrument until it is returned to our store, or is purchased. Failure to return rented property pursuant to the terms of this agreement may subject the Renter to criminal prosecution.
2. Renter assumes full responsibility for any damage, loss, or injury.
3. The rental instrument may not be removed from New York State without the written consent of Hermie's Music Store, Inc.
4. This contract may not be assigned without the written consent of Hermie's Music Store, Inc.
5. You must notify Hermie's Music store of any changes in address, phone, or credit card information.
6. All repairs to the rental instrument must be performed by Hermie's Music Store.
7. It is Renter's responsibility to make all payments on time. Hermie's Music Store need not give notice to Renter regarding Renter's obligation to pay.
8. 1.5% interest per month (18% per year) charged on all past due accounts.
9. No refunds will be issued on rental payments.
10. Except for string instruments, only one instrument exchange allowed per rental agreement. Rental fees will change if the exchanged instrument falls into a different instrument group category.
11. If you wish to purchase the rental instrument, a portion of your payments (up to 12 payments) can be credited toward purchase by arrangement with Hermie's Music Store, providing that all of your payments were remitted on time.
12. In signing of this agreement, you are authorizing Hermie's Music Store to charge any past due rental fees to your credit card when payments are not made within thirty (30) days of due date, along with the full purchase price of the instrument if it is not returned.
